

Hudson Jeans & *Ghost in the Shell* Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT IMPROVE YOUR CHANCES OF WINNING.

1. Eligibility

The Hudson Jeans & *Ghost in the Shell* sweepstakes (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are eighteen (18) years or older at the time of entry. Void in Guam, Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions and where prohibited by law. Officers, directors or employees of Hudson Clothing LLC, Paramount Pictures Corporation ("Paramount") or any of their respective affiliates, subsidiaries, parents, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Promotion (all such individuals and entities collectively referred to herein as the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such individual are not eligible to enter the Promotion or win a prize. The Promotion is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion. 2. Sponsor

3. Timing

The Promotion begins on March 2nd, 2017 at 12:00 a.m. Eastern Time ("ET") and ends on April 30th, 2017 at 11:59 p.m. ET (the "Promotion Period"). Sponsor's is the official time keeper for this Promotion.

4. How to Enter

During the Promotion Period, go to www.hudsonjeans.com/GhostInTheShell and completely fill out the online entry form by providing the required information and submit the online form. By submitting the online form you will be given an option to agree to sign up to receive emails from Hudson Jeans. You will receive one entry for providing the required information and you will receive additional entries when prompted to refer friends and family. Multiple participants are not permitted to share the same email address. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that participant's plays and that participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Sponsor and will not be returned. Sponsor reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion.

5. Winner Selection

On or about May 1st, 2017, Sponsor or an independent judging agency will select entrants for the prizes described below in Section 8 in a random drawing of all valid entries received during the Promotion Period. The entrants will be contacted using the email address provided with the entry and may be awarded the prizes (subject to verification of eligibility and compliance with the terms of these rules.) Sponsor's decisions as to the administration and operation of the Promotion and the selection of potential winners is final and binding in all matters related to the Promotion. Winners will be notified by email using the information provided at the time of entry on or about May 3rd, 2017. Failure to respond to the initial verification e-mail within five (5) days of notification or return of e-mail notification as undeliverable after three (3) attempts will result in disqualification.

6. POTENTIAL PRIZE WINNER IS SUBJECT TO VERIFICATION BY SPONSOR WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE PROMOTION.

7. Verification of Potential Winners

Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winners will be notified by email, after the date of random drawing. The potential winners will be required to sign and return to Sponsor, within ten (10) days of the date notice is sent, an affidavit of eligibility, and liability/publicity release (except where imposing such condition is prohibited) in order to claim his/her prizes if applicable. If a potential winner of any prize cannot be contacted, fails to sign and return the affidavit of eligibility and liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Up to FIFTY (50) MINOR PRIZES are available. Each Minor Prize winner will receive two (2) tickets to see *Ghost in the Shell* to a theater local to them. Movie tickets come in form of digital reward codes, that can be redeemed on the activate rewards website for movie certificates, worth up to \$13 each. See section 9 below for full ticketing terms and conditions. Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the prize for one of equal or greater value for any reason. Winner is responsible for all taxes and fees associated with prize receipt and/or use. Each winner will receive two reward codes via e-mail, each valid for a movie certificate good towards admission (up to \$13 total value) to see *Ghost in the Shell* at participating theaters in the U.S., at any showing including those designated as "no coupons, no passes" in local theater listing guides. Reward code void if not activated by 5/31/17, and certificate void if not used by 5/31/17 or when *Ghost in the Shell* is no longer in theaters, whichever comes first. If lost or stolen, cannot be replaced. No reproductions will be accepted. No cash value. No change will be provided. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

13. Limitations of Liability
